## Registration and reporting obligations 2024

From the period 1 April to 31 August 2024, companies covered by the producer responsibility for packaging in Denmark are obliged to:

#### 1. Register company (this guide)

2. Report expected quantities of packaging made available in Denmark in 2024

Both registration and reporting are done in VANA's Member Ponortal, after which VANA handles the reporting to Dansk Producentansvar (DPA). The Member Portal opens on March 25.

This guide describes how to register your company in the Member Portal.



### Registration via VANA.dk

Your registration starts on VANA's website under become a member here.

Both current and new members start the registration process here because this is our guarantee for having the correct and updated information on company and contact person.



#### What you need to have ready before you start


- Primary contact person: It is important that the contact person who will be the primary contact person for your producer responsibility is responsible for the establishment. (contact person may change afterwards, but must be done before registration of packaging quantities is submitted)
- MitID Erhverv: Registration requires validation with MitID Erhverv both when you register in VANA and when your information needs to be confirmed with DPA. It does not have to be the contact person who has access to MitID Erhverv, but there must be someone available at registration who has access to MitID Erhverv. If you are a sole proprietorship, MitID Privat can be used.

#### Creation of company and contact person in the Member Portal

#### 1. Company information

- CVR number: A check of the CVR number is made in the CVR register, which fills
  in available company information here. Any missing necessary information that
  cannot be found in the CVR register is filled in manually.
- Possible alternative billing address: The billing address will generally be the primary contact email address, unless other address is entered here. The billing address can also be changed in the Member Portal later.

Above/below 8 tonnes: If the company expects to make less than 8 tonnes of packaging available on the Danish market in 2024, tick the box. Deposit-refund and reusable packaging is exempt.




#### 2. Primary contact person

The primary contact person can invite and give authority to colleagues who need access to VANA's online Knowledge Universe (login to the website) and possibly also to report on behalf of the company in the Member Portal

Upon creation, the primary contact must accept:

- VANA's Privacy Policy
- VANAs Terms and Conditions, incl. VANA's Competition Compliance Guidelines and VANA's Code of Conduct.

After creation, a contract will be submitted, which must be signed by the authorized person in the company.



When information about the company and contact person has been filled in, the registration is completed with MitID Erhverv.

Contact person and MitID Erhverv holder do not have to be the same person.

NOTE! VANA will send invoice and contract no later than 1 May.

3. The creation is completed by following the instructions for creating a user profile and password for the Member Portal.

# Welcome to VANA A/S!

VANA submits your company registration and reported packaging quantities to DPA when the invoice has been paid and the contract has been signed.

Then you will receive a message from DPA to confirm the information VANA has reported on your behalf. In this connection, DPA will also charge their registration fee of DKK 1,000 (DKK 500, for companies already registered in DPA).
